The new title is Planning & Real Estate Analyst.

Chair Luedke requested a motion to approve the revised employment opportunity/job description. Director Becker made the motion; Dan Lauer seconded the motion. The following Resolution was adopted by the Board. Dr. Jim Gatling abstained.
